## Change starts with you...

**\$20 per week (\$ 1,040/year)** provides a weekend respite at a lake front lodge for a visually impaired child and their family.

**\$10 per week (\$520/year)** helps kids in school by providing a child with half an hour of tutoring a day for an entire year

**\$1 day (\$365/year)** helps develop early literacy in children by supplying 1 child with 60 books over a five year period

**\$5 per week (\$260/year)** provides 52 hours of tutoring, helping adults improve their literacy and essential skills so that they may increase their independence, go on to further education and training, or obtain/maintain work.

**\$2 per week (\$104/year)** helps provide 16 hot meals for a senior, helping them remain in their own home and receive the nutrition they need to maintain their health.
